RE: Unemployment compensation and alleged fraud issues

Dear Attorney General Kaul & Secretary Frostman:

The following organizations are writing to express our concern about the extreme racial disparities (as well as unreasonable victimization of Wisconsin residents) in the state's prosecutions for alleged unemployment fraud.

As of November 2018, data posted by an attorney who handles such cases indicates that 75% of the criminal unemployment fraud cases in Wisconsin were against African-Americans. *See* <a href="https://wisconsinui.wordpress.com/2018/11/27/criminalizing-unemployment-benefits/">https://wisconsinui.wordpress.com/2018/11/27/criminalizing-unemployment-benefits/</a>. This is a number obviously far disproportionate to the state's African American population. Nor does it reflect the actual distribution of the number of alleged concealment cases. Instead, it is based on a decision to target claimants in Milwaukee County (though in the past year or two there have been a handful of cases outside of Milwaukee County).

This disparity is particularly egregious because for several years the Department of Workforce Development has been charging people with unemployment concealment/fraud for unintentional or accidental claim-filing mistakes (and even when no mistake has occurred at all). Based on prior examination of these cases, it is very likely that a very large proportion — perhaps as much as 80% — of these criminal cases are based on similar accidental or unintentional claim-filing mistakes. So, the state is adding criminal charges when none previously existed while targeting a racial group that already suffers from a racial bias in criminal prosecutions and enforcement in this state. Furthermore, the Department has turned these concealment charges into a lucrative source of income for a specialized "program integrity" fund that is completely outside of legislative oversight and even public accountability.

Moreover, the state has routinely brought these cases against Milwaukee defendants in Dane County. Given that almost all of these defendants are poor and forced to travel – if they canfrom Milwaukee to Dane County for every stage of their cases, many defendants have taken plea deals of some kind in order to move on with their lives. Although it is our understanding that the Wisconsin Department of Justice has now put a temporary halt on these criminal cases, there remain hundreds of outstanding cases and prior plea deals affecting predominately African-American defendants. These cases must be re-examined in light of this obvious racial bias in these cases and vacated where the prosecution is based on unintentional or accidental mistakes.

In addition, this Administration should investigate why hundreds of African Americans were targeted and criminally charged under the prior administration, as well as how these concealment cases against folks for unintentional claim-filing mistakes could become so widespread, unchecked, and lucrative to a state agency originally designed to assist and support the unemployed.

We look forward to your response.
